Basic: State law (CA PRC 4291) requires that the roof and the first 30' from the house is clear of all flammable material ("green" plants are acceptable) and from 30' to 100' is either cleared of all flammable material or plants are pruned to an acceptable height (6' to 15' depending upon the slope and conditions) and accumulated pine needles, leaves and other burnable material are of a depth of no more than 4" (depending upon the surrounding vegetation).

FINANCIAL QUALIFICATIONS:

Inspection and contract coordination is free of charge to all those meeting the above age/disability qualifications. PC FSC has developed a co-pay formula for any contracted work to be done on an applicant's property based on an applicant's adjusted gross income. The co-payment is based on contractor bids that are usually less than \$1,000.
